Students found responsible for "Serious Offenses Involving Drugs and/or Alcohol (i.e. creating risk to self or others which includes, but is not limited to, physical violence, serious property destruction, or other serious infractions) may be suspended for that single violation. If not suspended, they will be placed on deferred suspension, with suspension occurring for any subsequent serious violation. Students placed on deferred suspension will not be permitted to affiliate with a fraternity or sorority in the semester the violation occurred or the following semester.

Students who are found responsible for violations involving Hard Alcohol will not be permitted to affiliate with a Fraternity or Sorority in the semester that the violation occurred or the following semester.
